A BYLAW OF THE SUMMER VILLAGE OF CRYSTAL SPRINGS IN THE PROVINCE OF ALBERTA TO SET FEES AND CHARGES FOR SERVICES PROVIDED BY THE MUNICIPALITY

WHEREAS the Municipal Government Act, R.S.A. 2000, c. M-26, and amendments thereto, provides that a municipality may pass bylaws for municipal purposes respecting services provided by the municipality; and

WHEREAS the Council of the Summer Village of Crystal Springs deems it desirable to establish fees and charges for the provision of certain goods and services.


NOW THEREFORE the Council of the Summer Village of Crystal Springs, duly assembled, hereby enacts as follows:


1. This Bylaw shall be known as "The Fees and Charges Bylaw"
2. The fees and charges attached as Schedule A to this bylaw represents the fees and charges applicable to the municipal services provided by the Summer Village of Crystal Springs, and the Schedule may be revised by resolution of Council.
3. Bylaw #152 is hereby repealed.
4. This Bylaw comes into effect upon third and final reading.

Read a third time and finally passed this 3rd day of June, 2010.

4. Assessment Information:
 - (a) For written information regarding the description of a parcel of land and the latest assessed value of the land and improvements thereon, as set out in the assessment roll: **\$10.00**

 - (b) For written information regarding the yearly assessments of a parcel of land, as set out in the assessment roll: **\$10.00**

5. Returned (NSF) Cheques: **\$20.00**

6. Administrative fee for each late payment and for any payment made by the Summer Village on behalf of Summer Village residents: **\$50.00**

7. Fees and charges pertaining to requests made under the Freedom of Information and Protection of Privacy Act RSA 2000 F-25, and amendments thereto, will be charged in accordance with Schedule 2 of Alberta Regulation 186/2008, Freedom of Information and Protection of Privacy Regulation and amendments thereto.
