Wastewater Projects

Pigeon Lake Regional Wastewater Committee

Mayor MacEachern updated Council on the Regional Wastewater Committee meeting held on October 21, 2009, and advised that Associated Engineering is to distribute the preliminary design study by November 16, 2009, with the next Committee meeting scheduled for November 24, 2009.

Local Wastewater Collection System

Council discussed the Wastewater Collection System Concept Design Study. Council discussed the need for other alternatives and indicated to Mayor MacEachern that more detail was required.

At 10:28 am Council welcomed Jeff Fetter of Associated Engineering. Mr. Fetter indicated that the Summer Village Council will need to make decisions prior to the detailed design stage (i.e. whether double/vacant lots will require service on both lots, as in the case of multiple lots owned by one owner).

Mr. Fetter also reviewed physical information (distance to road, existing utilities) and discussion took place regarding the use of grinder pumps or step pumps. The two types of pumps operate differently hydraulically, and while grinder pumps may be more costly to purchase, the need to have holding tanks cleaned is eliminated. Mr. Fetter stated that municipalities can not share a pipe to a lift station if the municipalities are using different types of pumps. Council discussed a preference for step pumps that require 220 volt power as they are alleged to be less expensive to maintain. Mr. Fetter also mentioned back-up power generators for the pump stations in case of power outages. Mr. Fetter will provide Council with cost comparisons for step versus grinder pumps. Council thanked Mr. Fetter and he left Council Chambers at 12:02 pm.

Trails

Councillor Hall has been in contact with the County of Wetaskiwin regarding trails in the Village at Pigeon Lake area to work together with the County in the establishment of trail systems to benefit all residents.

At the upcoming strategic planning session, Council and Administration will address the need for policy for the trail system in the Summer Village. This will be relayed to Messrs. Schlese and Johnson.

Newsletter

Council reviewed the draft newsletter and made suggestions for revision.

Capital Region Assessment Services Commission (C.R.A.S.C.)

Moved by Councillor Hall to advise C.R.A.S.C. that the Summer Village of Crystal Springs is interested in the proposed C.R.A.S.C. models relating to Assessment Complaints.


