**TO: PROPERTY OWNERS IN THE SUMMER VILLAGES OF CRYSTAL SPRINGS,
GRANDVIEW AND NORRIS BEACH**

RE: AMALGAMATION OF SUMMER VILLAGES

In the last two weeks four public forums were held for the purpose of communicating the intent, sharing information and seeking input with regard to the proposed amalgamation of the Summer Villages of Crystal Springs, Grandview and Norris Beach. The Amalgamation Committee appreciates the excellent attendance at the forums and the discussion. The Committee is hopeful that they adequately informed attendees of the administrative and operating efficiencies that will be gained by amalgamation.

Attached for the information of the people unable to attend the forums are the Q&A sheets handed out at the forums. This information is being distributed to enable all property owners to further consider the unanimous recommendation of all Councillors serving the three Villages.

A plebiscite to seek the formal approval of property owners is planned as follows:

Voting Requirements:

1. A person is only allowed to cast one vote for the municipality they are eligible to vote within, regardless of the number of properties they may own in that one municipality.
2. Any person named on the title is eligible to vote, providing they meet all the voter eligibility requirements in addition to being listed on the property title.
3. A person who owns property in the Summer Village, and meets the other voter eligibility requirements, is eligible to vote in each Summer Village that they own property within.
4. There are no other avenues to cast a vote if an elector is unavailable for the advance plebiscite or the actual plebiscite date.

It was explained at the forums that the final decision will be made by the Minister of Municipal Affairs after the plebiscites are conducted and after he has received a report from the Amalgamation Committee. Please make it a priority to vote at the plebiscites to secure the long term future of your Village. It is extremely important that all property owners express their opinion at the plebiscites so that the Minister is properly informed of that opinion and is able to confirm that the plebiscites were well attended.
