Mayor Keeler called the Meeting to Order at 9:00 a.m.

APPROVAL OF MINUTES FROM PREVIOUS MEETINGS

Moved by Councilor Hanson to approve the Regular Council Meeting Minutes of March 16, 2009 as presented.

DELEGATES & VISITORS

At 9:30 a.m. resident Donald Maygard, of Lot 12, Block 2, Plan 6215 NY presented several concerns to council regarding the need to clean the beach access and a drainage problem caused from a ditch adjacent to his property adjoining the village "turn-around road" located in front of Mr. Maygard's property. Mr. Maygard explained how he had previously spent his own money on a manhole.

Council held a discussion with Mr. Maygard in regards to hauling his own wastewater to a Lagoon. Council informed Mr. Maygard there is a concern with spills and the health and safety of other residents if residents were to haul their own wastewater. Council also informed Mr. Maygard that all residents are expected to hire a certified hauler.

Council explained to Mr. Maygard that the Summer Village is paving the turn-around this year which should improve the drainage problem by sloping the pavement. As Mr. Maygard uses the gravelled part of the road for parking his vehicle it would be appropriate for him to pay for paving that portion of the turn-around. Mr. Maygard is in agreement.

Mr. Maygard also had a concern about a beach access. Council agreed to look at improving the beach access by levelling with a backhoe. Levelling will improve the utilization of the access way. Work on the beach access will be a 2010 Budget item. Mr. Maygard has offered to volunteer to help clean-up the beach access areas. Council has agreed that they would only be trimming and that they were very concerned with preserving trees, rocks and bushes.

BYLAWS & POLICIES

Bylaw # 79 – Schedule A – A Bylaw to Control the Use of Fireworks

Council discussed Bylaw #79 and directed Administration to make changes that include the terms, "No person shall sell or set-off fireworks, no permitting of fireworks". Council also indicated that the fines are too low. A clause is needed to include the Federal Safety Code.

The Norris Beach application for an Internal Wastewater Collection System has been selected and can now apply under this new Infrastructure Stimulus Fund.

2009 Road Program

Border Paving has been awarded the contract for the 2009 road projects.

Culverts and Beavers

Alex Bauman removed one beaver dam and the culvert project is completed.

Uniform Quality Management Plan

Council reviewed the Uniform Quality Management Plan and recommended that Administration have the plan revised to read contract instead of employee and refer to Sections 3, 4 and 6. The plan should be changed to reflect this throughout the plan.


