Follow Up Sheet

Council reviewed the follow-up sheet and provided updates of action items. It was noted and appreciated that Councillor Hanson has offered to host a resident meeting regarding the playground. Mayor Keeler advised that one of the Norris Beach buoys is leaning due to low water levels and requested Administration to order a buoy with a shorter bottom "leg" that will allow the buoy to float.

Public Works Projects

The beaver dam will be left until next spring; at which time the contractor will be contacted to alleviate the issue.

Road Paving

Border Paving will commence work in September to add another lift of pavement. They may also be performing work on the trail system to prevent further pavement crumbling if this is viewed as a viable option.

Wastewater Bylaw Review

The draft bylaw and meeting with Alberta Municipal Affairs were discussed; further advice with legal counsel will be obtained. Deputy Mayor Fowlie will send an update to Grandview Council for their information.

Strategic Plan

Council will review the draft Strategic Plan and discuss potential revisions and additions at the next Council meeting.

Pigeon Lake Watershed Association – Water Balance Study


